Announcements, Correspondence, & Reports

<u>Williams Annual Report</u> – Mike Brown reported on the Williams annual report by the Lake County Office of Education. The report states we met all the requirements of instructional materials, school facilities, SARC, teacher misassignments and the reporting of complaints.

<u>Technology Update</u> – Mike Brown reported a new set of Chromebooks were purchased to replace old and non-working laptops in the upper grade classrooms.

<u>AVID Update</u> – Megan Grant reported that we received a positive certification. She had the opportunity to teach a model lesson in a 4th grade classroom. Megan has been hosting an AVID hour each month and had a good turnout of teachers at the last meeting. Teachers will be conducting the next AVID assessments in January 2018.

<u>2016/2017 Physical Education Testing Results</u> – Mike Brown reported on the following fitness areas, aerobic capacity, body composition, abdominal strength, trunk extension strength and upper body strength. Physical education testing is completed annually schoolwide, although, only 5th and 7th grades are reported to the state. The total number of 5th graders tested was 25. The total number of 7th graders tested was 19.
