Dear Parents & Guardians,

Lucerne Elementary School receives Title One federal funding to assist our students in academic achievement in reading, writing, and math. The *No Child Left Behind* law requires that all Title One schools make adequate yearly progress (AYP) in improving student achievement. Each year, results on the California Standards Test in English Language Arts and Mathematics are analyzed and matched with the achievement targets. When a school fails to meet these achievement targets for two consecutive years, it is identified as a Program Improvement school. A school exits Program Improvement after two consecutive years of reaching the target.

Unfortunately, the California Department of Education has not yet returned school wide test results to us and most likely will not until early October. At the very least Lucerne Elementary school will remain in Year 1 of Program Improvement (PI) and could possibly move into Year 2. The *No Child Left Behind* Law target is 100% of students will test proficient or advanced by the year 2014. As a Year 1 or 2 PI school, we will ensure that students have access to quality educational programs. We are reviewing student programs and will begin to use strategies designed to improve the curriculum and student performance. We will revise our policies and practices to incorporate research-based strategies to strengthen core academic areas that ensure all groups of students meet the achievement standards. Our district is working closely with Lake County Office of Education and the California Department of Education. They are providing resources, support, and training opportunities in areas of high quality professional development. We are analyzing various data reports that are strengthening our core academic instruction that will lead to removing our school from PI status. If we move into Year 2 PI, Supplementary Education Services will be offered to eligible students. Those services would consist of after school tutoring and other possible academic intervention. More information will follow when scores are made available.

State law referred to as the Open Enrollment Act, requires us to inform parents of students who attend the elementary school that you have right to request a transfer for your child to another school. Under this law you may request a transfer to another school that is not in PI. All of our neighboring districts as well as many districts outside of the county are also in Program Improvement. Most school districts in Lake County already support the concept of Open Enrollment, as they believe in the participation of parents in their students' educational choices and have given parents the opportunity to enroll their children in other districts for many years. Within the *No Child Left Behind* law, parents of students attending a Year 1 Title I Program Improvement school may send their child to a non-Program Improvement school in the district and receive transportation to a designated district school at district expense. However, Lucerne Elementary School District has only one elementary school. Lucerne Elementary School strongly encourages and appreciates parent involvement in student education. As a K -8 district there are numerous opportunities for participation.
